# A. Privacy Policy

Effective date: 31 October 2025

We appreciate your visit to our website and we value your privacy. This Privacy and Cookie Policy explains how FUMEX BV ("FUMEX", "we", "us", "our") collects, uses and protects your personal data in accordance with the General Data Protection Regulation (EU) 2016/679 (GDPR), the Belgian Data Protection Act of 30 July 2018, and other applicable privacy legislation.

## 2. Purposes and Legal Bases for Processing

We process your personal data for the following purposes, based on the following legal grounds under Article 6 GDPR:

- To perform a contract with you (Art. 6(1)(b));
- To comply with legal obligations (Art. 6(1)(c));
- $\bullet$  For our legitimate interests in improving our services and communications (Art. 6(1)(f)), unless unless overridden by your interests or rights;
- Based on your consent for marketing activities or non-essential cookies (Art. 6(1)(a)).

**Automated decision-making / profiling:** We do not use your data for automated decision-making that produces legal or significant effects concerning you.

## 3. Categories of Data

We may collect and process the following categories of personal data:

- Identification and contact data (name, address, email, phone number);
- Financial and transactional data (payment details);

- Website usage data (cookies, IP address, device information);
- Marketing preferences and communications.

#### 4. Data Retention

We retain your personal data only as long as necessary for the purposes for which it was collected or as required by law:

- Customer data: up to 10 years after last contact;
- Marketing data: until consent is withdrawn or after 3 years of inactivity;
- Cookies and consent records: for the duration indicated in our cookie table or up to 12 months for consent records.

#### 5. Data Transfers

FUMEX may transfer personal data outside the European Economic Area (EEA). In such cases, we ensure adequate protection by:

- Relying on an EU adequacy decision (e.g. EU-US Data Privacy Framework), or
- Using the European Commission's Standard Contractual Clauses (SCCs).

## 6. Data Recipients

We share your personal data only when necessary with trusted processors, including MailerLite, Google Firebase, and IT service providers. Each partner is bound by a data processing agreement in accordance with Article 28 GDPR to ensure equivalent levels of security and confidentiality.

## 7. Rights of the Data Subject

You have the right to:

- Access your data and obtain a copy;
- Request rectification or erasure;
- Restrict or object to processing;
- Withdraw your consent at any time;
- Request data portability;
- Lodge a complaint with the Belgian Data Protection Authority.

FUMEX applies appropriate technical and organisational measures to secure your personal data and prevent destruction, loss, alteration or unauthorised access. #### 9. Minors

We do not knowingly collect personal data from children under 13 years of age without parental consent. Parents are encouraged to supervise their children's online activity. If you believe we have collected such data, please contact us for prompt deletion.

# 10. Jurisdiction and Applicable Law

This Privacy Policy is governed by Belgian law. Only the courts of the judicial district of Brussels have jurisdiction over disputes concerning this Policy.

# **B.** Cookie Policy

This Cookie Policy explains what cookies are, how we use them, and how you can manage your preferences.

#### 1. What Are Cookies?

Cookies are small text files stored on your device when visiting a website. They help the site function properly, improve security, and provide insights into usage for performance and marketing.

## 2. Types of Cookies Used

- Essential cookies required for core functionality.
- Functional cookies support non-essential features such as embedded videos.
- Analytics cookies help us understand how users interact with our website.
- Marketing cookies used to deliver relevant advertising.
- Preference cookies store user settings such as language.

## 3. Legal Basis for Cookies

Essential cookies are installed automatically. Non-essential cookies (analytics, marketing, etc.) are placed only after you have given explicit consent through our cookie banner. You

may withdraw or modify your consent at any time.

## 4. Managing Cookie Preferences

On our website a cookie banner is displayed when you first visit. The banner offers clearly two equal and visible buttons: "Accept all cookies" and "Reject all non-essential cookies". The "Reject" option is presented with equal prominence as the "Accept" option. Non-essential cookies (e.g., analytics and marketing) are blocked until you make your choice. You may also choose which categories to accept or reject via the "Cookie Settings" panel. No non-essential cookie is set or executed before you give your active consent.

When you open the Cookie Settings panel, no non-essential cookie category is activated by default. You must opt-in to each category individually if you wish

You can withdraw or change your consent at any time with the same one-click ease as you originally gave it, via the "Cookie Settings" link available on our website

In addition to this, different browsers provide different methods to block and delete cookies used by websites. You can change the settings of your browser to block/delete the cookies.
